* NOTICE TO MEMBERS

YOU ARE HEREBY ADVISED OF YOUR RIGHT UNDER ARTICLE V, SECTION 4 OF THE CREDIT UNION'S BYLAWS TO SUBMIT TO THE CREDIT UNION'S CHAIRPERSON ON OR BEFORE JANUARY 31, 2026, A PETITION REQUESTING YOUR NOMINATION AS A NOMINEE TO THE CREDIT UNION'S BOARD OF DIRECTORS. YOUR PETITION MUST BE SIGNED BY AT LEAST FIFTEEN (15) MEMBERS ELIGIBLE TO VOTE AT MEETINGS OF THE MEMBERS OF THE CREDIT UNION. IF NO PETITIONS ARE SUBMITTED THESE MEMBERS WILL BE ELECTED BY DEFAULT. IF NO MEMBER SUBMITS A PETITION, THE CHAIRPERSON SHALL TAKE A VOICE VOTE OR DECLARE EACH NOMINEE ELECTED BY ACCLAMATION AT THE ANNUAL MEETING AND THERE SHALL BE NO ELECTION BY MAIL BALLOT.

24TH ANNUAL H.P. HECKENDORF COMMUNITY SERVICE AWARD

The H.P. Heckendorf Community Service Award honors individuals who demonstrate outstanding community service and volunteerism. The recipient receives a commemorative plaque, \$250, and a matching donation to a charity of their choice.
